# ST MARY'S CHURCH CHEVELEY 200 CLUB RULES

The purpose of the lottery is to raise money for St Mary's Church, Cheveley for a long term project to redevelop the building and give it a new lease of life for future generations to enjoy. As previous generations have done, we wish to create a more flexible space or we may be in danger of closing.

An Administrative Committee, comprising the Promoter, an Administrator, Administrator's assistant and a salesperson will run the club. Shares will be sold at £5 per month for a minimum contract period of 12 months payable by Standing Order either monthly or annually in advance for £55. Only persons who are members of the club will be allowed to participate. Money paid for shares will not be refundable should a member wish to discontinue membership. A bank account will be opened into which all receipts will be paid and from where payment of prize money will be issued.

A monthly prize will be dependent on the number of members, but it is proposed that this will be 40% of the amount invested each month after expenses. These must not exceed 10% of total proceeds in any 12-month accounting period. If we have 200 members, this will produce an income of £1000 per month and prize money of £400, split into three - £250, £100, £50.

The winning numbers will be drawn normally on the 1st Sunday of the month, but may be changed if it coincides with local events. This will allow adequate time to check the amount received in any month. Only numbers for the shares sold and paid for will be entered into each monthly draw. This will provide a better chance of winning.

A list of winners will be posted on the Church notice board in the porch, and on our website <a href="https://www.cheveleygroup.org">www.cheveleygroup.org</a>.

A register will be kept of members, prizes paid out, funds paid into the P.C.C. and annual returns to E.C.D.C. After payment of prize money and expenses, the balance will be transferred to St Mary's Church, Cheveley Parochial Church Council bank account on a half yearly basis or as necessary.

Share certificates will only be valid for the period that subscriptions have been paid. In the event of a dispute, the Administrative Committee's decision is final.



## **OUR PLAN**

We continue to look at ways to update and/or upgrade the church facilities. Having completed our toilet extension in 2020 and redecoration of the South Transept in 2023/4, we turn our attention to the repair and restoration of our 1874 Norman & Beard Organ.

The long-term aim is for further modernisation, with improved lighting and updated flexible seating . This will provide a more adaptable and friendly space with better access, for all the usual activities of a parish church (worship services, prayer meetings, youth events, baptism, weddings, funerals, etc.) and a wide range of community activities, school visits, concerts, exhibitions, performances, and meetings.

The modernisation will be done in several phases as time and money allow. Firstly, however, we need to start with a programme to repair and restore parts of the organ, many of which are showing their age.

The result will be a instrument in tune and available for all those who wish to play it.
